#### **BE ADVISED:**


- 1) PLEASE DO NOT TRAVEL OFF-ROAD IN ANY TYPE OF VEHICLE

  - The items include, but are not limited to: <u>RAILROAD TIES, RAILROAD ROCKS, OR OTHERWISE ASSOCIATED RAILROAD MATERIALS</u>.
    Many man-made items found on camp navajo are HISTORIC & CULTURALLY SIGNIFICANT ARTIFACTS <u>SEVERE PENALTIES AND FINES MAY RESULT</u>.
- 3) PLEASE <u>PAY ATTENTION TO</u> AND <u>ABIDE BY</u> ANY **NOTIFICATION**, WARNING, OR OTHER ADVISORY SIGNS PLACED THROUGHOUT Arizona Garrison Training Center, Camp Navajo.



## Munitions and Explosives of Concern (MEC) Brief





MEC include but are not limited to: Ammunition, Bombs, Bulk TNT/CR, Cartridges, Fuzes, Grenades, Mines, Missiles and Rockets

Things to Consider: MEC can be anywhere. Not all MEC can bring items to the surface. Retreat at least 2,000 NAAD-01 for emergencies and/or wildfire

Recreational User Requirement: Report to Post 3 daily

## Munitions and Explosives of Concern (MEC)









- Entry: Authorized by Garrison Command and must have UXO-qualified escort.
- ▶ Entry Requirements Include: MEC training, 2-way radio and/or cell phone, and first aid kit.
- <u>Restrictions</u>: Ammunition, explosives, fireworks and ignition sources prohibited. No smoking. "Dig" and CNFD Permits required. No removal of soil/MD. NO SMOKING.
- Consequences: Soldiers/CN personnel = GC notification Rec users/Contractors = privileges revoked and removal from installation.
























## Munitions and Explosives of Concern (MEC)

In the event MEC are discovered, the following procedures will be taken:

- ► Recognize Recognizing MEC is key to reducing the risk of injury or death. If an object is encountered that is suspected to be MEC, consider it extremely dangerous.
- ▶ Retreat Do not touch, move or disturb it, but immediately and carefully do not run leave the area following the same path on which the area was entered. If possible, mark the general area, not the munition, in some manner (e.g., with a hat, piece of cloth, or tying a piece of plastic to a tree branch).
- ► Report Trespassers and activities occurring w/out a permit. If suspect MEC is encountered, immediately contact Camp Navajo Security at (928) 637-0864. Report:
  - The suspect MEC location.
  - Direction to the item.
  - Any landmarks or other features (such as sticks, rocks, flags, clothing) that would aid in locating the suspect MEC.
