



# Arizona Mutual Aid Compact (AZMAC) Signatories

**Yellow:** Jurisdictions that are signatories to the previous version of AZMAC dated October 1, 2008. The October 1, 2008 version is still enforced and valid for a period of 10 years after the filing date. Expiration dates for the 2008 compact are included on the spreadsheet.
