AREA OF CONSIDERATION: This position is open to current members of the Arizona Army and/or Air National Guard in the grades of: O3 to O4. Individual selected will receive an FTNGD-OS Tour with the Arizona Army and/or Air National Guard. For other services, equivalent retirement points statement. Must be within 1 year of Annual Ending Date;
- 4. Most recent Medical Protection System Individual Medical Readiness (IMR) Record accessible through Army Knowledge Online (AKO). The IMR must be dated within the last 12 months to be valid;
- 5. DA Form 4970 Cardiovascular screening (over 40 Soldiers) if applicable
- 6. Copy of most recent ACFT (DA Form 705-TEST). Profiles must be attached, if applicable.

MINIMUM APPOINTMENT REQUIREMENTS:

- 1. Must meet the medical fitness standards for retention per AR 40-501, chapter 3
- 2. Must meet the physical requirements of AR 600-9
- 3. Acceptance of a position at Peace Vanguard TERMINATES entitlements to the Selected Reserve Incentive Program (SRIP).
- 4. PCS may be authorized for this position. Authorization of payment of PCS expenses will be granted only after a determination is made that PCS is in the best interest of the Peace Vanguard program and upon availability of funds from the Program Manager
- 5. Must not be flagged in IPPS-A for weight, security violations or pending adverse actions
- 6. Soldier's grade must be commensurate with the grade of the vacancy on Peace Vanguard's TDA/Manning Document; voluntary demotions will not be authorized.
- 7. Orders are subject to availability of funds.
- 8. Applicant cannot reach 18 year lock (Exception: Current AZARNG AGRs with approved temporary release request). DARNG Waiver request must be submitted prior to acceptance of position for those with 17 years of Active Federal Service (AFS) or more.
- 9. Applicant cannot be in violation with the 1825 Rule
- 10. Orders will go until the end of the current Fiscal Year (FY), with the possibility of continuation depending on funding.

BRIEF JOB DESCRIPTION:

Responsible for managing ~\$37M dollars of foreign military sales (FMS) three-year case funds in direct coordination with United States Army Security Assistance Command (USASAC) and Republic of Singapore Air Force. Supervises all logistical operations in support of the United States Army Flight Training Detachment as the Senior Logistics Officer. Assists with administrative, logistics and maintenance operations in support of Peace Vanguard's mission. Establishes resources and money for all unit movements and operations. Budgets all FMS funds through GFEBS and advises the Commander on status of funds. Directly supervises one Logistics Officer and oversees the operations of the unit S-4. Directly supervises unit Contract Specialist (O-2/O-3) co-located with AZ USPF&O and oversees all required contract activities. Facilitates GSA credit card inspections and supervises all billing official transactions and funding. Establishes memorandums of agreement (MOAs) with all state supporting entities (G3, G4, CFMO, USPF&O and G1). Facilitates ammunition movement and control from Camp Navajo in support of the unit mission. Supervises the GSA program and fuel purchase cards from DLA. Other duties as assigned as one of three field grade officers in the unit.
