SUMMARY OF DUTIES: The primary purpose of this position is to serve as the Unmanned Aircraft Systems (UAS) Standardization Instructor Operator (DO/IO) primary Training Administrator for the Tactical Unmanned Aircraft System Operating Facility (TUASOF) Commander.

HOW APPLICANTS WILL BE ASSESSED: If your resume does not include a narrative description of how you meet the SPECIALIZED experiences and OTHER requirements, you may lose consideration for this position.

SPECIALIZED EXPERIENCE: Must possess 48 months experience, education, or training routine and non-routine preflight, in-flight, post-flight, ground or command and control (C2) duties according to specific transportation functions. Receives, interprets, extracts, and disseminates relevant data for mission planning or execution. Experience coordinating and negotiating with organizations/personnel both orally and in writing to resolve differences/problems.

CONDITIONS OF EMPLOYMENT & NOTES:

- Must be able to obtain and maintain a secret security clearance of the position.
- The incumbent may occasionally be required to work other than normal duty hours.
- May be required to travel by car, in military and/or commercial aircraft, and by other means of transportation as appropriate, to perform temporary duty assignments.
