Service Members will be in a State Active Duty (SAD) status in accordance with Ariz. Rev. Stat. Title 26.

Arizona Service Members in a SAD status will not receive federal orders, will not receive federal pay or benefits, and will not receive a DD 214 for service purposes.

All hiring and benefits will be based on the DEMA Directive 25.8, State Active-Duty, dated 1 July 2022 and the State of Arizona Accounting Manual (SAAM) Issued 01 October 2018.

SAD Members must meet all application requirements and must not have a suspension of favorable actions.

All SAD members are required to report to M-Day IDT/IAD and complete Annual Training (AT).

## JOB DESCRIPTION

The following position is being recruited: Port of Entry (POE) Assistance in Southern Arizona.
