- Owner of RV or boat agrees to hold Camp Navajo Training Site harmless for any liabilities arising from storage of said items. Owners of RV's and boats agree to maintain insurance on vehicles at all times for theft, vandalism, fire, public liability, property damage and collision. Camp Navajo Training Site does not provide insurance for RV's and Boats stored on the premises, included but not limited to fire, vandalism, weather and / or criminal / negligent action.
- All customers will pay 30 days in advance and submit fees monthly thereafter.
- All customers must notify the billeting office, in writing, 30 day prior to cancellation or changes in the storage agreement.
- It is the property owner's responsibility to notify the Camp Navajo Training Site for periods of time during the billing period that the property will not be stored at Camp Navajo.
- Storage charges will continue to accrue unless termination notice is received in writing and property is timely removed.
- Park in the space assigned to you. If someone else is parked in your space. **NOTIFY THE BASE OPERATIONS SUPERVISOR IMMEDIATELY. (PHONE # 773-3238)**
- Access to the storage facility is only during our posted business hours (**Monday – Friday, 0700hrs to 1530hrs**). **CUSTOMERS ARE REQUIRED TO SIGN IN AND OUT UPON ENTERING OR LEAVING THE PREMISES.**
- I acknowledge that Camp Navajo Training site reserves the right to initiate legal recourse for accounts 60 days past due.
- A Camp Navajo Training Site representative will be with you at all times, while moving vehicles in and out of storage area.
- Only the owners of items stored in the area shall be permitted to remove the item. The owner of the item must submit a designee should a third party desire to remove the item from the storage area.

**RV / BOAT STORAGE RATES:**

Flat rate charge of \$.75 per vehicle per day. Total length of RV not to exceed 50'. Vehicles over 50' in length must be approved by the Garrison Commander. Vehicles with more than two axles will be accessed a charge of \$.25 per axle per day.

Flat rate charge of \$.75 per boat per day. Total length of Boat not to exceed 50'. Boats over 50' must be approved by the Garrison Commander and are dependent upon availability of space. Boat trailers with more than two axles will be accessed a charge of \$.25 per axle per day.
