AREA OF CONSIDERATION: This position is in the Active Guard and Reserve Force and is open to to current members of the Army National Guard in the Grade of E5. Individual selected will receive an Active Duty Title 32 Tour with the Arizona Army National Guard. In order to be considered for this position, applicants must meet minimum qualifications as outlined on the reverse of this announcement.

NOTE: Selection for this position requires declaration of Arizona state residency at the time of in-processing, and maintaining that residency while on AGR status under Title 32, USC.198012

NOTE: Applicants must be 92Y MOSQ or be able to become 92Y MOSQ within 12 months of being hired.

APPOINTMENT REQUIREMENTS:

1. Must meet the medical fitness standards for retention per AR 40-501, chapter 3.
2. Soldiers must meet the physical requirements of AR 600-9.
3. Must have the potential to become MOS qualified in the first 12 months or be released from AD/FTNGD.
4. ARNG applicants must be able to serve at least 3 years in AGR status prior to completing 18 years of Active Service or mandatory removal from active service based on age or service (without any extensions) under any provision of law or regulation as prescribed by current directives.
5. AGR soldiers will not be reassigned during the first 36 months of their initial tour except in the event of mobilization, force structure changes, or an exception to policy granted by the Recruiting and Retention Commander.
6. Must possess the grade equal to or below that authorized for the AGR duty position.
7. Acceptance of an AGR position **TERMINATES** entitlements to be Selected Reserve Incentive Program (SRIP).
8. Permanent Change of Station (PCS) expenses may be authorized for this position. Authorization of payment of PCS expenses will be granted only after a determination is made that PCS is in the best interest of the Arizona Army National Guard and upon availability of funds from the National Guard Bureau.
9. Additional qualification requirements are outlined in NGR 600-5, AR 135-18 and other applicable regulations and laws governing the Active Guard/Reserve Program.
10. Must not be flagged in SIDPERS for weight, APFT, security violations or pending any adverse actions
11. Applicants who answer YES to questions 8, or 12-16 of section IV, NGB Form 34-1, or have not completed Initial entry training (IET) are ineligible to apply. to include DD214(s) that have unfavorable remarks to include; unsatisfactory Performance, Misconduct, Dropped from the Rolls (DRF) Unsuitability/Unfitness or in lieu of court-martial AR 135-18, AR 135-91 Chapter 4,26, AR 135-178 Chapter 8,3 and 635-200 Chapter 11.
12. Individuals selected for AGR tours that cannot obtain 20 years of Active Federal Service prior to reaching mandatory separation, must complete a statement of understanding acknowledging this fact. Waiver authority rests with the Human Resource Officer for non-control graded positions and with National Guard Bureau (NGB) for control Graded positions

KNOWLEDGE, SKILLS AND ABILITIES REQUIRED FOR SUCCESSFUL PERFORMANCE IN THIS POSITION OR THE MOS PREREQUISITES:

- (1) A physical demands rating of heavy.
- (2) A physical profile of 222222.
- (3) Qualifying scores.
 - (a) A minimum score of 95 in aptitude area CL in Armed Services Vocational aptitude Battery (ASVAB) tests administered prior to 2 January 2002.
 - (b) A minimum score of 92 in aptitude area CL on ASVAB tests administered on and after 2 January 2002 and prior to 1 July 2004.
 - (c) A minimum score of 90 in aptitude area CL on ASVAB tests administered on and after 1 July 2004.
- (4) Normal color vision.
- (5) Mandatory formal training.

BRIEF JOB DESCRIPTION: Coordinates supply activities, preferred that applicants have working knowledge of LIW, ASEIP, FEDLOG, GFEBs and PBUSE. Determines method of obtaining relief from responsibility for lost, damaged and destroyed supply items. Responsible for ensuring the WAATS is logistically ready to complete its TDA mission. Ensure that all Soldiers receive OCIE issue and prepare and process personnel clothing request through central clothing distribution facility. Maintain hand receipts for property book items issued by pilots and supporting soldier members within the WAATS organization. Ensure that all supported personnel receive prompt and courteous service. Prepare expendable/durable supplies and equipment for issue or turn-in as required. Provides inventory lists for all storage of training aid containers. Must be able to pass a financial background check. Will be appointed as a IMPAC card holder; guarantee that all purchases made with the IMPAC credit card are needed and accounted for and receipts are processed for pay in a timely manner. Maintain accountability of all laundry items which are issued and received. Request, maintain, and account for all expendable supplies ordered. Provide dormitory rooms for all students attending schools located at the WAATS; as well as additional personnel requiring support from the WAATS. Maintains and operates key card swipe system (KABA) and manages placement of all Soldier members. Performs recon on PBUSE, and maintain status of expendable equipment. Will be required to process transactions within general fund enterprise business system. Any other duty that may arise not outlined within the scope of work. Must have or be able to qualify for a secret clearance. Must have a valid state driver's license.
