AREA OF CONSIDERATION:

This position is in the Federal/Excepted Civil Service and is **open to current members and those eligible for membership in the Arizona Air National Guard.** Individual selected will receive an **Indefinite Appointment** and may be converted to permanent based on availability of funds or position no longer being encumbered. Acceptance of a Federal Excepted technician position of over 179 days in length will cause termination from the Selected Reserve Incentive Program (BONUS). Individual selected will require a military medical records screening if applicable, to be completed prior to appointment, and/or may be required to take a pre-employment medical screening examination dependent on the position type and military medical records screening results.

INSTRUCTIONS FOR APPLYING: Individuals applying for vacancies with the Arizona National Guard may submit Optional Form 612 (Optional Application for Federal Employment), or a Resume. Application documents must contain the Announcement Number, Title and Grade(s) of the job being applied for. KNOWLEDGE, SKILLS AND ABILITIES REQUIRED FOR SUCCESSFUL PERFORMANCE IN THIS POSITION:

1. Ability to communicate effectively both orally and in writing.
2. Experience or training utilizing principles, basic functions and application of theory of electronic integrated systems equipment.
3. Experience in diagnosing problems and determining needed repairs for malfunctions of electronic integrated systems equipment.
4. Experience in using a wide variety of test, measurement and diagnostic equipment (TMDE).
5. Experience which demonstrates the ability to interpret technical manuals, specifications and publications.

SPECIALIZED EXPERIENCE: Must have at least 30 months of specialized experience working as an Electronic Integrated Systems Mechanic, AND must possess a 7-level in any of the following AFSC: 2A0X1, 2A2X1, 2A2X2, 2A2X3, 2A3X4, 2A3X5, 2A8X1, 2A8X2, 2A9X1, 2A9X2, 2A9X3, and knowledge and skills to install, modify, overhaul, maintain, troubleshoot, repair, align, calibrate, and rebuild multi-system avionics complexes consisting of multiple completely integrated electronic avionics systems where the complex accomplishes a number of major functions. Experiences included the ability and skills to perform on-or off-equipment maintenance on one or more complete electronic integrated systems associated with the assigned aircraft and/or maintenance on systems such as, automatic flight control systems, instrument systems, inertial and radar navigation systems. Experienced in performing scheduled and unscheduled maintenance on one or more multi-complex electronic integrated systems. Experiences included completing operational checks, inspections, tests, trouble shooting, removal and replacement of line-replaceable-units which are linked with integrated systems and line-replaceable-units which are independent or associated with nonintegrated systems. Must have skilled capabilities of isolating unusual malfunctions using technical orders, schematics, wiring diagrams, tools, and test equipment including automatic test equipment and flight line test systems.

BRIEF JOB DESCRIPTION: This position is located at the 162d Wing, Tucson, Arizona, Maintenance Group, Aircraft Maintenance Squadron Avionics workcenter that supports aircraft. It is an Air National Guard dual status technician position that requires military membership, compatible military skill assignment and classification. The primary purpose of this position is to install, modify, overhaul, maintain, troubleshoot, repair, align, calibrate and rebuild multi-system

complexes, which consist of several complete integrated electronic avionics systems, where the multi-system complex accomplishes a number of major functions. Install, modifies, overhauls, maintains, troubleshoots, repairs, rebuilds, aligns and calibrates complete electronic avionics multisystems. Troubleshoots malfunctions and analyzes system performance utilizing aircrew debrief data, Technical Orders, schematic and wiring diagrams, engineering drawing, data downloads from various systems, waveform analysis from Time Domain Reflectometer and Joint Services Electronic Combat Test Set (JSECTS), Multiplex Bus Fault Isolation Test Set, common and system specific test equipment and built in system tests. Removes faulty system components and line replaceable units, (LRUs). Installs serviceable components and LRUs or repairs faulty wiring as required. Recommends hardware and software changes. Submits change recommendations to Technical Orders. Requisitions supply assets and processes repairable assets in accordance with Standard Base Supply system requirements. Documents maintenance action in aircraft forms and documents man-hour expenditures and maintenance actions in the computer system. Provides training to lower graded and newly assigned personnel concerned with the repair of integrated avionics systems. Prepares for and participates in AEF taskings, deployments and various inspections and exercises. Complies with safety, fire, security and housekeeping regulations. Ensures that material and equipment are properly stored, protected and maintained. May be required to perform additional duties such as launch and recovery, aircraft servicing, firefighting, aircraft crash and rescue duty or serve as a member of a natural disasters or civil emergencies team. Position subject to rotating work schedule.
