AREA OF CONSIDERATION:

This position is in the Federal/Excepted Civil Service and is **open to current members and those eligible for membership in the Arizona Air National Guard.** Individual selected will receive an **Indefinite Appointment** and may be converted to permanent based on availability of funds or position no longer being encumbered. Acceptance of a Federal Excepted technician position of over 179 days in length will cause termination from the Selected Reserve Incentive Program (BONUS). Individual selected will require a military medical records screening if applicable, to be completed prior to appointment, and/or may be required to take a pre-employment medical screening examination dependent on the position type and military medical records screening results.

INSTRUCTIONS FOR APPLYING: Individuals applying for vacancies with the Arizona National Guard may submit Optional Form 612 (Optional Application for Federal Employment), or a Resume. Application documents must contain the Announcement Number, Title and Grade(s) of the job being applied for. Personal information must include full name and address (including ZIP Code), Day and evening phone numbers (with area code). Work experience information should be limited to either paid or nonpaid experience directly related to the position that the individual is applying for and must include: Job Title, Duties and accomplishments, Employers name and address, Supervisors name and phone number, starting and ending dates, hours per week and salary.

4. Knowledge of job safety, fire, security and housekeeping regulations.
5. Skilled in the use of hand tools, precision measurement devices, appropriate diagnostic equipment and rig fixtures.
6. Ability to effectively communicate orally and in writing.

SPECIALIZED EXPERIENCE:

WG – 5: Must possess at least 6 months experience or training which demonstrates the ability to learn basic electrical and mechanical principles. Experience which demonstrates the ability to learn procedures used to perform hydraulic and pneumatic system checks. Experience in identifying basic malfunctions when source of trouble is easily located by appearance, sound, or response. Experience which demonstrates the ability to learn procedures used to service, maintain, disassemble, assemble and repair aircraft pneudraulic systems/components. Experience using various hand tools. Experience which demonstrated the ability to follow written instructions.

WG – 8: Must possess at least 12 months experience or training which provided a knowledge of basic electrical and mechanical principles. Experience in fabricating fuel, oil and vacuum hose lines. Experience in servicing, maintaining, repairing and testing hydraulic and pneumatic systems. Experience in repairing, rebuilding and overhauling major components of pneumatic and hydraulic systems. Experience in mechanical repairs using hand tools and test equipment. Experience that demonstrates the ability to interpret technical manuals, specifications and publications.

BRIEF JOB DESCRIPTION: This position is located at the 162nd Wing, Tucson, AZ, in a National Guard aircraft maintenance organization. Its primary purpose is to perform on- and/or off-equipment maintenance on assigned aircraft pneudraulic systems, components and related aerospace ground equipment. Work involved in the maintenance, modification, and repair of hydraulic and pneumatic systems associated with aircraft. The work requires: knowledge of the physical principles governing the behavior of fluids (liquids and gases) as they pertain to hydraulic and pneumatic systems and their components; knowledge of aircraft structures and the relationship of hydraulic pneumatic systems to the structure and other aircraft systems; knowledge of basic electrical and mechanical principles; the ability to use technical manuals and schematics and to test for and isolate malfunctions in hydraulic and pneumatic systems; and the skill to effect modifications, repairs, or maintenance required
