**AREA OF CONSIDERATION:** Must be a current member of the AZ National Guard within the grade(s) of O1 and O4. Individual selected will receive Active Duty Title 32 Tour with the Arizona Air National Guard. In order to be considered for this position applicants must meet minimum qualifications. PCS funds are authorized.

The following items are mandatory for all AGR announcements: NGB 34-1, Detailed Resume, Virtual MPF RIP, AF Form 422, Copy of Current Fitness Test, Written explanation is required for any missing documents. All other documents are encouraged but optional:

1. Completed NGB 34-1
  2. Detailed Resume with dates of employment (military and civilian) and contact information.
  3. AZ vMPF RIP. RIP can be obtained from the servicing Military Personnel Flight (MPF). In lieu of a RIP, applicant may provide a printout from the Virtual MPF (vMPF). Select 'Record Review' and then 'Print/View All Pages'. For Enlisted Members, documents MUST show your ASVAB scores.
  4. Copy of current Fitness Test scores, if exemptions exist please include the AF 469. Must be within 12 months.
  5. AF Form 422, Physical Profile Serial Report and DD Form 2992 (flight status only). Must be current within 12 months, this form can be obtained from your Wing Clinic.
  6. AZNG 335-1-R / Military Brief
  7. AZ Form 34-1, Arizona AGR Application Supplement
  8. Letter of verification of Security Clearance from local Security Manager.
  9. Memorandum in Lieu of any missing or flawed required documents.

**POSITION COMPATIBILITY REQUIREMENTS:**

**The individual(s) must be a member of the Arizona AIR National Guard and qualify for and be placed in the following compatible AFSC prior to starting AGR tour: 18X**

**MINIMUM APPOINTMENT REQUIREMENTS:**

1. Must possess rank 2Lt/O1-Maj/O4.
  2. Must be eligible for AFSC 11U3A/18A3A
  3. Must possess TS/SCI Clearance
  4. Placement/Promotion is contingent upon Control Grade Availability

**ADDITIONAL REQUIREMENTS:**

1. Must be in compliance with physical fitness, height, weight, and body fat measurement standards as listed in AFI 36-2905.
  2. If selected member is pregnant, orders may commence as long the member can safely perform duties within the restrictions of the AF 469 and with chain of command approval.
  3. If required, we will initiate an investigation for a security clearance. Unfavorable results will be cause for your immediate separation.
  4. Individuals who cannot obtain 20 years of Active Federal Service prior to reaching mandatory retirement, age 60 for enlisted personnel, or mandatory separation date for officers, IF SELECTED you must submit a Waiver for Exceptional Circumstances to their HRO remote, through the HRO with final approval at the Air Component Commander level. Waivers must justify why it is in the best interest of the unit, State, or Air National Guard.
  5. You must meet eligibility requirements of AFI36-2101 Classifying Military Personnel (Officer and Enlisted) and ANGI 36-101 (The Active Guard/Reserve Program).
  6. Individuals selected for Control Grade positions are subject to Control Grade availability.

**EVALUATION PROCESS:** Each applicant must FULLY SUBSTANTIATE on their application how they meet the requirements listed in the advertised position; otherwise applicant will be considered unqualified for this position. Applications will be evaluated solely on information supplied in the application (NGB Form 34-1) or resume. Experience will be evaluated based on relevance to the position for which application is being made. Include job titles, starting and ending dates (month and

year), hours per week, salary, duties/accomplishments, employer(s) name and address, and supervisor(s) name/phone number and permission to contact.

**BRIEF JOB DESCRIPTION:**

This position is located at the 214th Attack Group, Davis Monthan AFB, Tucson, AZ. The primary purpose of this position is to both personally pilot and to instruct others in the piloting of highly advanced military Remotely Piloted Aircraft (RPA) which involves such functions as launch and recovery, surveillance, surface attack, full scale weapons employment, mortar to arm escort, killer scout, target illumination, laser targeting, functional flight tests, and flight testing. This position description is designed for those National Guard unmanned aircraft where the pilot is issuing flight control commands directly to the aircraft via “stick and rudder” as opposed to those where the operator inputs flight and navigational commands into a flight control system which determines the appropriate “piloting” actions. The incumbent performs limited supervisory duties over a small number of RPA pilots and instructor pilots.
