- Owner of RV or boat agrees to hold Camp Navajo Training Site harmless for any liabilities arising from storage of said items. Owners of RV's and boats agree to maintain insurance on vehicles at all times for theft, vandalism, fire, public liability, property damage and collision. Camp Navajo Training Site does not provide insurance for RV's and Boats stored on the premises, included but not limited to fire, vandalism, weather and / or criminal / negligent action.
- Camp Navajo shall not store cars, trucks or vans for any reason including a TDY or deployment of Soldier or service member. Only the items listed above in the vehicle section are acceptable storage items.
- **CUSTOMER SHALL PAY IN ADVANCE OF PLANNED USAGE/STORAGE.** Customer may chose to leave approved item in storage lot longer, but must ensure continued payment. Upon sixty (60) days of delinquency, Camp Navajo and the Arizona National Guard reserve the right to request Coconino County Sheriff's Office to remove the item.
 - Patron acknowledges that Camp Navajo Training site reserves the right to initiate legal recourse for accounts 60 days past due.
- It is the property owner's responsibility to notify the Camp Navajo Training Site for periods of time during the billing period that the property will not be stored at Camp Navajo. **CUSTOMERS WHO PAY IN ADVANCE & REMOVE THE ITEM FOR ALL OR PART OF THE PRE-PAID TIME SHALL NOT BE REFUNDED FOR TIME THE ITMES IS NOT STORED.**
 - If multiple items are stored by one patron there shall be no reallocation of funds or refunds for the removal of one or more of the items within a pre-paid time period. (Each item is charged separately by day, even if paid on one money order or check).
- Storage charges will continue to accrue unless termination notice is received in writing to MWR Coordinator by mail; 1 Hughes Ave, Bellemont Az 86015 or email; ng.az.azarnng.mbx.mwr@mail.mil. Property will be removed from Camp Navajo RV Storage in a timely manner.
- Only the owners of items stored in the area shall be permitted to remove the item. The owner of the item must submit a designee should a third party desire to remove the item from the storage area.

RV / BOAT STORAGE RATES:

Flat rate charge of \$1.00 per vehicle per day. Total length of RV not to exceed 50'. Vehicles over 50' in length must be approved by the Garrison Commander.

Flat rate charge of \$1.00 per boat per day. Total length of Boat not to exceed 50'. Boats over 50' must be approved by the Garrison Commander and are dependent upon availability of space.

All fees must be paid by personal check, cashier's check or money order, **NO CASH** shall be accepted. Check or money order may be written to "State of Arizona".
